**ENTRY FORMS ARE DUE JULY 1**

- **Corrections can be made if an entry blank has been received and an exhibitors number assigned.**
- Exhibits must have been made or grown by the exhibitor anytime from August 1, 2007 to July 8, 2008 (July 9 for foods).
- **All entries (other than Horticulture) will be accepted for display in the the general exhibit area on the fairgrounds between 5 p.m. and 8 p.m on Monday July 7 or between 10 a.m. and 4 p.m. on Tuesday July 8. PLEASE NOTE THE CHANGE IN TIMES.** (Call Sharon Stillings at (651)633-8577 if you have questions). **Food items will also be accepted on Wednesday, July 9 from 8 a.m. to 10 a.m. Horticulture entries will be accepted on Thursday morning, July 10 from 7:00 to 10 a.m. Rose Show entries will be accepted Saturday morning July 12 from 7 to 10 a.m.**
- All exhibits must remain at the fair for the duration of the fair. All possible care will be taken to prevent damage or loss, but in no event will the County Fair management be responsible for damage or loss. No soiled articles will be accepted.
- **Limit (1) entry in each lot number.** Grand Champion ribbons will be awarded at the discretion of the judge in all divisions.
- **ALL EXHIBITS MAY BE REMOVED BETWEEN 9 P.M. AND 10 P.M., SUNDAY, JULY 13 or BETWEEN 8 A.M. AND 11 A.M. ON MONDAY, JULY 14. PRESENT ENTRY SHEET TO PICK UP ITEMS IN EACH DIVISION. We will mail premium checks and ribbons awarded to anyone who cannot pick up their perishable/disposable exhibit.**
